Dear Chairman Moran and Vice Chairwoman Shaheen,

As you prepare to mark up the Fiscal Year (FY) 2019 Commerce, Justice, Science (CJS) appropriations bill, we are writing on behalf of The Census Project (<a href="www.thecensusproject.org">www.thecensusproject.org</a>), a broad-based network of business, civic, and academic groups committed to a full, fair, complete, and accurate 2020 Census, to express support for funding the U.S. Census Bureau. Specifically, we urge the Subcommittee to match the funding level that the House Appropriations Committee approved in its version of the FY 2019 CJS bill.

After years of delayed and insufficient funding, Census stakeholders are grateful for both the generous appropriation and flexible spending authority the Census Bureau received in the FY 2018 omnibus appropriations bill. Further, we are pleased that the House Appropriations Committee has prioritized funding for the Census Bureau in FY 2019, allocating \$4.799 billion for the Census Bureau, almost \$2 billion above the FY2018 appropriation, \$999 million above the administration's request, and almost \$70 million more than census stakeholders recommended.

FY 2019 is a pivotal year for 2020 Census preparations and the last opportunity the Bureau has to ensure information technology systems and new operations are in place for a successful decennial census. Additional investments are necessary for the Bureau to build upon momentum that the FY 2018 omnibus bill provided and fully launch all operational and administrative aspects of the 2020 Census. These activities include completing all address canvassing operations, opening Area Census Offices, finalizing IT systems readiness and security, and recruiting and hiring approximately 76,000 personnel.

The additional funding that the House Appropriations Committee recommended would allow the Bureau to initiate and expand other activities that have lingered as a result of recent budget cutbacks and delays. These activities would include increasing the number of partnership specialists or assistants from 1,000 to 2,000; expanding targeted advertising and promotion to hard-to-count communities as part of the Communications Campaign; and broadening the agency's 'field footprint' through more local census offices or questionnaire assistance centers, thus ensuring a greater presence in every region of the country in light of a lower projected self-response rate. Support for these additional outreach and education activities is particularly important, given Commerce Secretary Ross' recent decision to add an untested citizenship

question to the 2020 Census —which could discourage participation among certain hard-to-count communities. The additional funding should also enable the Bureau to continue its other activities, which include conducting the ongoing American Community Survey and other demographic and economic surveys, and to establish a \$300 million plus contingency fund as it has for past decennials in the event of IT failures or natural disasters, including hurricanes and wildfires, related to the 2020 Census.

Fiscal Year 2019 is a critical year on the path toward the decennial census—our nation's largest, most complex peacetime mobilization. The census is one of the federal government's few constitutionally required activities and is the basis for apportioning seats in the U.S. House of Representatives. Decennial census data are the foundation of our democracy, influencing a wide range of decisions in the private and public sectors. These decisions include the allocation of more than \$800 billion in federal assistance annually, industry investments, and state and local government planning.

In closing, we thank you once again for working with your colleagues in the House in FY 2018 and recognizing the significance of the Census Bureau's work as it prepares for the 2020 Census. We urge you to continue making key investments in the Census Bureau by providing the agency with \$4.8 billion in FY 2019.

Thank you for considering our views and working with census stakeholders to ensure the Census Bureau has the resources and spending flexibility it needs to conduct an inclusive, accurate, and efficient 2020 Census.
