## BUDGET RECONCILIATION



- House and Senate must adopt identical budget resolutions setting overall spending and revenue levels for a specific period (usually 10 years)

- Includes reconciliation instructions to committees with specific targets



COMMITTE

- Identified committees draft legislation based on reconciliation instructions

- House and
Senate Budget
Committees
package their
chambers'
respective bills
into an omnibus



3. FLOOR CONSIDER

- Each chamber considers its respective omnibus package

- A simple majority is needed to pass through the chamber



- A conference committee works to reconcile differences between the two bills

 If agreement is reached, each chamber votes on the final package SIGNED INTO LAW OR VETOED

- Once the House and Senate each pass an identical bill, it goes to the President for signature or veto.





#### BUDGET RECONCILIATION

- This week: House Armed Services, Homeland Security, Education and Workforce, Judiciary, Financial Services, and Oversight and Gov't Reform Committees
- House Energy & Commerce Committee's bill may be released next week
- House passage target: Memorial Day
- Senate passage target: July 4
- Hard deadline: September 30



#### Regular Order:

- FEB President's Budget Request released; Congressional Committees begin hearings
- APR Congress adopts budget resolution
- MAY Appropriations Committees set allocations for 12 subcommittees
- MAY-JUN Subcommittees write and "mark up" bills
- JUN Full Appropriations Committee considers/amends bills
- JUN/JUL House/Senate floor debates/vote on each bill individually
- SEP Differences negotiated (conference committee), each chamber votes on compromise
- BY SEP 30 To the President to sign/veto
- OCT 1 New fiscal year begins



- President's Budget Request Any day now...
- Leaked HHS draft budget
  - NIH reorg collapsing its 27 ICs into 8
  - 40% cut to the NIH budget, decreasing to \$27.3 billion
  - 44% cut to the CDC budget, decreasing to \$5.2 billion
  - Codify 15% NIH indirect cost rate
  - Administration for Community Living Zeroed Out
  - Create new Administration for a Healthy America (AHA), which would absorb:
    - Maternal and Child Health
    - Mental Health
    - Environmental Health
    - O HIV/AIDS






#### RESPONSES

- Minority Staff Report released: "Defending the Hidden Figures: A Rebuttal of Erroneous Attacks on Merit-Based, Fair, and Competitive STEM Grants"
  - Cruz report contains a "slew of embarrassing mistakes."
  - It disregards Congressional statutes, including broader impacts criterion.
  - "The authors lack a basic understanding of how [NSF] awards are selected, the scientific literacy to discern technical terms with multiple meanings, and an understanding of laws, even those supported by Sen. Cruz himself, that protect these activities."
- Rep. Lofgren sends letter to NSF Director
- Requests more information on NSF's process for reviewing grants for alignment with Trump values by April 24
  - Director resigns April 25

  - Encourage academic freedom express disagreement respectfully
